	During the quarter, the Company received a short-term, interest-free, limited recourse loan from shareholders of \$2,000,000, repayable on 31 December 2023 which may be offset against any future capital raising by the Company. The lenders received 6.67 million options exercisable at \$0.25 each expiring 30 April 2023. All the lenders, elected to convert their debt to shares under the Entitlement Offer which closed on 28 September 2022. The shares will be issued to the lenders on completion of the Shortfall Offer.
