Answer: Yes. Additional Gemcorp facility of \$7.7m available and revenue from sales will commence in the next quarter. Also, development costs will decrease with construction to be completed next quarter.

Answer: No, not required due to availability of finance facility and expected commencement of sales in the next quarter.
