Answer: Yes. Cash receipts from graphite sales will progressively increase in the next quarter and development costs will decrease from previous quarter with completion of construction.

Answer: The Company is reviewing credit approved overdraft facility term sheets from local Tanzanian banks. The company is yet to commit to any of these facilities.
